**Note :-**  
1) As per Section 173(1A) of CrPC, the investigation in relation to an offence under sections 376, 376A, 376AB, 376B, 376C, 376D, 376DA, 376DB or 376E of the Indian Penal Code shall be completed within two months from the date on which the information was recorded by the officer in charge of the police station. The said report is designed for supervision and compliance of provision defined under section 173 (1A) of CrPC.  
2) Count reflected in front of all the above heads do not follow Principle Offence Rule. The count reflected is of the cases which are regstd. with POCSO or without POCSO which will not match with the count reflected in Rape head of IPC.  
3) The Total count will not match with the count of Rape Offences displayed in the IPC chart.
